Effective October 26, 2022, the Adviser has contractually agreed to waive its management fees and/or to reimburse expenses so that the total annual operating expenses (excluding interest, taxes, brokerage commissions, acquired fund fees and expenses and extraordinary expenses) were limited to the following amount of average net assets: SA US Fixed Income - 0.40%, SA Emerging Markets Value - 1.04%, SA Real Estate Securities - 0.75%. This agreement to waive fees and/or reimburse operating expenses with respect to the SA US Fixed Income, SA Emerging Markets Value and SA Real Estate Securities will remain in effect until October 28, 2025, at which time it may be continued, modified or eliminated and net expenses will be adjusted as necessary.
